<u>Mary Louise Steele</u>, of Lebanon, died on 7 Feb 2015 and was buried in the <u>Kirker Cemetery</u> in Adams County, Ohio. Mary has been a WCGS member since 2004 and was a regular at our monthly meetings held at Otterbein. Mary was also a member of the National Society United States Daughters of 1812 and the National Society of the Daughters of the American Revolution. William has been a WCGS member since 1999 and became First Families of Warren County member #62, in 2002, having proven his descent from **Jonathan Fox**, **Hannah Espy**, **Hannah Dearth** and **Frederick Cline** who settled in Deerfield Township in the 1798-1800 time period. The State of Ohio, Warren County

Application for Naturalization

Personally appeared in open Court, **Dennis Davis** an applicant for naturalization, who on being duly sworn according to laws deposeth and saith that he is at this time forty one year of age, that he was born in the county of Yorkshire in the Kingdom of Great Britain from whence in the year of our Lord eighteen hundred and ten, he being then a minor under the age of twenty one years to wit in his seventeenth year of age, he emigrated to the United States of America, that he now resides and has continued to reside in the United States from that time until the present moment, that he has resided for two years past within the county of Warren in the State of Ohio. And the said **Dennis Davis** further saith that during the time he has resided in the United States as aforesaid he has been attached to the principles of the Constitution of the United States, and well disposed to the good order and happiness of the same; and that it has been his bona fide intention for more than three years past, and it is now his bona fide intention to become a citizen of the United States; and he further saith upon his solemn oath; that he will support the Constitution of the United States; and that he doth absolutely and entirely renounce and abjure all allegiance and fidelity to any foreign prince, potentate, state or sovereignty whatever and particularly he renounces all allegiances and fidelity to his Majesty William the IV King of Great Britain, Ireland Scotland &c. in whose dominions he was heretofore a subject. And the said **Dennis Davis** also saith that he has never borne any hereditary title or been of any of the orders of nobility in any country whatever.

WAR OF 1812 PENSION DIGITIZATION PROJECT

We are excited to report that our 2015 fund raising drive in support of the War of 1812 Pension Digitization project has resulted in a total of \$1,830 donations from members and friends of the Warren County Genealogical Society.

The Warren County Genealogical Society is matching the first \$500 of these contributions. In addition, both the Federation of Genealogical Societies and Ancestry.com will match our total contributions.

We have estimated that about 136 pension files with a total of about 5000 pages will have a connection to Warren County. Our combined donation easily covers the cost to digitize those files and a lot more. Thanks to all that participated.

=> VETERAN PHOTOS AND DOCUMENTS:

=> WAR OF 1812 PENSION FILES:

In November, the pension files on line at Fold3.go up to the **Simeon Moore** name in Ohio. We know of about 82 pension files containing 2,977 pages that have been digitized for soldiers with a connection to Warren County. Thanks to the blog posting of the Warren County Record Center and Archives, we are able to add the name of <u>Isaac Beller</u> to the list of War of 1812 veterans with a connection to Warren County. <u>Warren County Records Center and Archives Blog</u> - <u>Nov. 10, 2015 Happy Veterans Day</u> Information on the internet indicate that Issac was born in Beckley, Virginia ca. 1787 and moved to Warren County with a brother, Peter Beller who also served in the War of 1812.

Isaac is listed as insane and living in the Warren County Infirmary in both the 1850 and 1860 census. He is not listed in the <u>War of 1812 Pension and Bounty Land Warrant Application Files</u>," on Fold3 but we were able to locate the bounty land warrants that he was awarded.

- <u>Bounty Land Warrant#47248</u> for 80 acres was issued under the Act of 1850 in favor of Isaac <u>Ballar</u> Private <u>Captain</u> <u>Fordyce's Company</u> Ohio Militia War of 1812. The warrant was assigned to **John P. Crothers** who was issued a patent for 80 acres in Livingston County, Illinois on 1 Mar 1854.
- <u>Bounty Land Warrant #3443</u> for 80 acres was issued under the Act of 1855 in favor of Isaac Bellar, Private, <u>Captain</u> Fordyce Company Ohio Militia War of 1812. The warrant was assigned by **William Frost**, Guardian of Isaac Bellar, to **Jacob Egbert** and by him to **Robert Milton Perrine** in whose favor a patent was issued for 80 acres in Cass County, Iowa on 1 May 1860.

Warren County Probate Court Records contain petitions to sell his warrants at public auction and an accounting of the proceeds, all filed by **William Frost** who was appointed his guardian on 2 Jul 1852. <u>Click here</u> to see abstracted entries.

Complete pension files are now on line for widow certificate numbers up to about 148,100. The pension file for <u>Benjamin Franklin Duke</u> was located in the last month.

Jemima Duke (Certificate #51833) mother of Benjamin Franklin Duke [23 images]

Franklin Duke was enrolled on 5 Sep 1861 by <u>Capt. O. H. Parshall</u> at Lebanon Ohio in Co. F, 35th OVI for a term of three years and mustered in as a musician (fifer) in Co. F on 9 Sep 1861 at Camp Hamilton. He was described as being 34 years old, born in Jefferson County, Virginia, 5' 7 1/2" tall, dark complexion, black eyes, brown hair and by occupation a cordwainer [shoemaker]. He was afflicted with chronic diarrhea while in the vicinity of Somerset, Kentucky and sent to hospital in Nashville about 15 Mar 1862 and died there on 30 Mar 1862 leaving no widow or children. He is supposed to be buried in the Nashville National Cemetery.

Jemima Duke was the widow of John Duke who died in Virginia about 18 years ago (ca. 1846) and the mother of the late Benjamin Franklin Duke

on 18 Jul 1864, **Jemima Duke** of Springboro, aged nearly 75, appeared before Probate Court Judge **Jno. C. Dunlevey** to make a declaration in order to obtain the benefits provided by the Act of 1862 (Application #58139). **Aaron Gregg** and Mrs. **Christiana Vickers** witnessed her declaration which was attested by **Geo. W. Smith & Josiah Morrow**. **D. Allen** of Lebanon was her attorney. **Jemima Duke** was awarded a pension of \$8 per month commencing 30 Mar 1862 by Certificate #51833 dated 24 Jul 1865.

We provided them with 3 obituary databases covering different time periods that are now searchable on the OGS website at http://www.ogs.org/research/search_warrenobit.php

This database is an index to 92,642 obituaries located in our Resource Library The page numbers listed in the index are the page in our obituary binders and not the page in the newspaper. You don't have to be an OGS member to use this tool. If you join OGS as a new member, you may designate that Warren County receives a \$5.00 rebate from their new membership application.
