WARREN COUNTY PROBATE COURT JUDGES

Hello All! The Records Center & Archives has recently received a request for help in acquiring images of all prior judges of the Warren County Probate Court. As you can imagine, this has been a tedious process. Luckily, we are down to only three judges missing! This is where you come in. We are looking for photographs, drawings, sketches, etc. that would be able to be reproduced for public viewing on a larger scale in the current Probate & Juvenile Courthouse. The three judges we haven't been able to find are: **James C. Sabin** (1816-1860), **William W. Wilson** (1831-1885), and **Thomas R. Thatcher** (approx. 1836-1894). Judge Sabin served from 1858-1860, Judge Wilson served from 1865-1869 and part of 1872, and Judge Thatcher served from 1869-1872. Any help you could possibly give would be greatly appreciated. ALLEEN STEPHENSON DIGITAL NEWSPAPER PROJECT - WESTERN STAR ANALYTICS

Since the fall of 2018, our Alleen Stephenson Digital Newspaper Project, sponsored and maintained by the Warren County Genealogical Society, has provided free public access to digital images of the Western Star from 1807 through 1922 on the <u>Ohio</u> <u>Memory Project</u>. In the 4th quarter of 2019, the site was used by 1,294 visitors in 1,939 sessions to make 28,594 page views. Since the project went on line in 2018, 4,169 users have made 149,382 page views. WAR OF 1812 PENSION AND BOUNTY LAND WARRANT APPLICATIONS

The digitization of the <u>War of 1812 Pension and Bounty Land Warrant Application Files</u>, was on hold once they completed adding the pension files for surnames beginning with the letter \mathbf{Q} . The project has resumed with surnames beginning with \mathbf{RO} . In the Ohio pensioners, they are now up to the name **Seth St. John**.

Seth St. John (ca. 1792 - 1874) Corporal, Capt. Robert Hays' and Captain John Sheets' Company, Colonel James Findley's Regiment, Ohio Militia

<u>Findagrave Memorial ID 102893739</u> for **Seth St. John** (1792-1874) buried in the Pine Village Cemetery in Warren County, Indiana contains an image of Seth and lists him as the son of **John St. John** (1870-1819) and **Anna Lockwood** (1754-1830. His parents are buried in the <u>Bethel Baptist Church Cemetery</u> in Turtlecreek Twp.

War of 1812 Pension and Bounty Land Warrant Application Files," fold3.com, Seth St. John (34 pages)

- On 22 Aug 1869, Seth St. John and Anna Myers were married by William A. Fisher J.P. in Warren County, Indiana. Seth St. John died near Pine Village, Warren County, Indiana on 24 Aug 1874. The pension file does not indicate when his wife died.
- Bounty Land Warrant No. 21333 for 160 acres was issued under the Act of 1850 to Seth St. John Corporal in Captains Hays and Sheets companies Ohio Militia War of 1812. Seth was issued a patent for 160 acres in Livingston County, Illinois on 9 Oct 1854.
- On 5 Apr 1871, **Seth St. John**, aged 78, of Pine Village PO, Warren County, Indiana, made a declaration before the county circuit court clerk for the purpose of being placed on the pension rolls under the Pension Act of 1871 (Application No. 7559). His place of abode was within 1/2 mile of the village. The declaration was witnessed by **George W. Nordurff** and **Joseph H. Brown**. In his declaration he said, "he volunteered in Captain **Robert Hays** Company, Regiment commanded by Col. James Findley Ohio Militia at Warren County Ohio on the 10 day of April 1812 and was honorably discharged. He was mustered in at Lebanon Ohio. Company joined the Regiment at Dayton Ohio. The Regiment under Col. James Findley marched to Detroit where we was placed under command of General Hull and was by General Hull surrendered on _______ day of August 1812. After the surrender by Hull and paroled we were taken to Cleveland Ohio and ordered home. Afterward and at Lebanon Oho we were given Certificates of service by our officers which I filed in the War Dept at the time I got Land Warrants for my service above named"
- Seth's pension application (No 7559) was first rejected on 5 Sep 1871 for insufficient service, based on 11 days of service in Capt. Hays' Company after the Declaration of War and not considering his service in Capt. John Sheets' Company. On 27 Sep 1871, **Seth St. John**, aged 78 of Pine Village, Warren County, Indiana filed a supplementary declaration stating he "enlisted at Lebanon Ohio about the 10 day of Apr 1812 for one year and was surrendered by Gen. Hull at Detroit Mich. about the 16 day of August 1812. That while we were marching toward Detroit and in the wilderness Capt. Hays resigned. That we got to Detroit about the first of July we elected John Sheets Capt. and Samuel Miller Lieut. who continued as company officers at the time we were surrendered at Detroit by Gen. Hull."
- On 9 May 1872 the Third Auditor issued a new report indicated that **Seth St. John** enlisted 27 Apr 1812 in Capt. **Robert Hays'** Company, Ohio Militia and was discharged 27 Jun 1812. He served afterward from 28 Jun 1812 to 26 Apr 1813 in Capt. **John Sheets'** Company Ohio Militia. Length of service 313 days subsequent to the Declaration of War on June 18th 1812. **Seth St. John** was admitted to a Survivors' Pension under the Act of 1871 of \$8 per month commencing 14 Feb 1871 by Certificate No. 16832 dated 17 May 1872.
- On 30 Sep 1878, **Anna St. John**, aged 74 years, of Rainsville Post Office, Warren County, Indiana, made a declaration before the circuit court clerk for the purpose of obtaining a widows' pension under the pension Act of 1878 (Application No.

33632). She declared that she was the widow of **Seth St.John** who was a member of Capt. **John Ferris** Company of Col **James Findley** Regiment Ohio Militia who enlisted on 10 Apr 1812 and honorably discharged in June 1812. Her declaration was witnessed by **Isaac N. Statzell** and **Jonathan C. Hall**, both residents of Rainsville. **John McBride** and **Samuel C. Fisher** made a declaration that they were neighbors for 25 years and confirmed Seth's death about 21 Aug 1874. **Anna St. John** was admitted to a Widows' Pension under the Act of 1878 of \$8 per month commencing 9 Mar 1878 by Certificate No. 19482 dated 4 Mar 1879.

ROOTSWEB MAILING LISTS

It was announced January 7, 2020 that the Rootsweb genealogy mailing lists will be discontinued and archived. Below is a copy of the announcement.

Beginning March 2nd, 2020 the Mailing Lists functionality on RootsWeb will be discontinued. Users will no longer be able to send outgoing emails or accept incoming emails. Additionally, administration tools will no longer be available to list administrators and mailing lists will be put into an archival state. Administrators may save the emails in their list prior to March 2nd. After that, mailing list archives will remain available and searchable on RootsWeb. As an alternative to RootsWeb Mailing Lists, Ancestry message boards are a great option to network with others in the genealogy community. Message boards are available for free with an Ancestry registered account. Thank you for being part of the RootsWeb family and contributing to this community.
